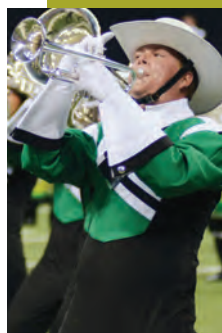

Students come away from camp with much more insight into the music, the art of performing and the art of experiencing jazz!

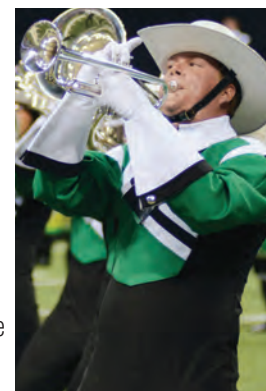

# 2012 Bands of America Grand National Championships in Review

November 7-10, 2012

Lucas Oil Stadium, Indianapolis, IN

Lucas Oil Stadium has seen its share of big-ticket events this year, starting with the Super Bowl and continuing with the Drum Corps International World Championships and then the Music for All Bands of America Grand National Championships. The stadium has imprinted itself on the psyches of countless pageantry arts fans and the most recent BOA show has done nothing to lessen that.

The four days of events were presented by Yamaha, a company whose commitment to Music for All and thousands upon thousands of music students only grows as it marches through the second year of its second half century in America.

After Prelims on Thursday and Friday, the following 33 bands (listed in performance order) advanced into Semi-Finals: Norton HS (OH), Forest Park Jr./Sr. HS (IN), La Salle HS (OH), Western HS (IN), Bellevue West HS (NE), Goshen HS (IN), Bridgewater-Raritan HS (NJ), Nation Ford HS (SC), Ben Davis HS (IN), William Mason HS (OH), Franklin HS (TN), Ronald Reagan HS (TX), Centerville HS (OH), James Bowie HS (TX), Marian Catholic HS (IL), Greenwood Community HS (IN), Center Grove HS (IN), Avon HS (IN), Lafayette HS (LA), Kennesaw Mountain HS (GA), Carmel HS (IN), North Hardin HS (GA), Plymouth-Canton Educational Park (MI), Rockford HS (MI), George Walton HS (GA), Tarpon Springs HS (FL), Union HS (OK), Lawrence Central HS (IN), Broken Arrow HS (OK), Lake Central HS (IN), Bourbon County HS (KY), Jenison HS (MI), Walled Lake Central HS (MI) and Northmont HS (OH).

After the performances of all Semi-Finals bands and the exhibition of the Western Carolina University Marching Band, caption and

placement awards were presented to the top bands in each of the four competitive Semi-Finals classes.

In Class A, Western HS won Outstanding Music Performance, Norton HS won Outstanding Visual Performance, and Forest Park Jr./Sr. HS won Outstanding General Effect. Western took 1st place in the class, followed by Forest Park in 2nd and Norton in 3rd.

Class AA Outstanding Music Performance, Outstanding General Effect and a tie for Outstanding Visual Performance went to Tarpon Springs HS, with Marian Catholic HS also tying for Visual Performance. Tarpon Springs took 1st place, Marian Catholic 2nd and Nation Ford HS 3rd.

All three Class AAA awards went to Kennesaw Mountain HS, which took 1st in the class, followed by Franklin HS in 2nd and Bellevue West HS in 3rd. In Class AAAA, Outstanding Music Performance went to Carmel HS, a tie for Outstanding Visual Performance honors went to both Carmel and Broken Arrow HS, and Outstanding General Effect went to Broken Arrow. Carmel took 1st place, Broken Arrow 2nd and James Bowie HS 3rd.

Finals started with an exhibition by the Class A Champion Western HS band and concluded with the announcement of scores during the finale. The Honor Band of America Drum Line, in Indianapolis to prepare for the Tournament of Roses® Parade, played all finalist bands onto the field for the finale, which also included a performance by American Idol performer Shaun Canon.

In Finals, Grand Champion Carmel received an invitation to perform in the 2014 Pasadena Tournament of Roses® Parade, and also took the Outstanding Music Performance Award. Broken Arrow won the Steve Brubaker Outstanding Visual Performance Award and the Outstanding General Effect Award. For the first time ever, the Al Castronova Espirit de Corps Award was won by two bands. Bridgewater-Raritan HS of New Jersey came to Indianapolis less than two weeks after living through the devastating effects of

Hurricane Sandy and was hosted and cared for by Avon H.S. (IN) band members and supporters. The story of these two bands served as inspiration at an event that saw members of all bands share a sense of camaraderie and the joy of music with each other.

**Carmel H.S., IN** • A Tangled Web We Weave was built around the children's song, "Itsy Bitsy Spider." Nine geodesic dome structures provided nesting places for the guard of black widows, with a large meandering drill form spider menacingly surveying the audience for its next meal. Despite gingerly navigating the webbing, the entire band became caught in it at the end, with no hope of escape. *1st place: 95.85*

**Broken Arrow H.S., OK** • Gas mask-wearing band members escaping the smoke of an ash heap-laden battle zone captured the horror of war in the otherworldly landscape of Surrender to Hope. From opening war drums through air raid sirens and to the engulfing of the band by giant explosions of fabric, this show threw one eerie effect after another at the corneas and eardrums of the shell-shocked audience. *2nd place: 95.70*

**Avon H.S., IN** • The overindulgence of extreme opulence heartlessly contrasted with the scarcity faced by the common folk in Feast or Famine, providing a pitying-yet-sometimes humorous look at conditions leading up to the French Revolution. Banquet table gluttony and pies in the face mocked the conditions of the downtrodden, highlighting a cultural disparity with parallels to today's society. *3rd place: 93.90*

**Tarpon Springs H.S., FL** • Poisoned told the Brothers Grimm fairytale story of Snow White and her nemesis, the envious queen. The word "EVIL" appeared in the drill as the queen entered atop the backs of her servants, as well as the poisoned apple form presented to Snow White. The drabness of the queen was offset by the vivid colors of Snow White, constantly reminding us who is naughty and who is nice. *4th place: 93.80*

**Marian Catholic H.S., IL** • Man's inhumanity to man and the choice between non-violent coexistence and violent co-annihilation was highlighted in My Brother's Keeper. Music pierced like stabs to the soul while the band formed a giant chain of oppression. Concentration camp survivors watched over the devastating folly, ending with the resonating caution of Martin Luther King's 1967 "Beyond Vietnam" speech. *5th place: 92.90*

**James Bowie H.S., TX** • Dome tents as planetary spheres drifted slowly through the heavens, as Stellae Errantes (The Wandering Stars) brought the solar system within telescopic view, illuminating the firmaments with LED lighting on the uniforms and guard equipment. Comets raced past the stars and within the orbits of the constellations, presenting an aura of grandeur on an intergalactic scale. *6th place: 89.85*

**Kennesaw Mountain H.S., GA** • Everyone loves a circus, but one might be wary of staying too long at the dark carnival hallucination of Deliver Me. Whimsical with a sinister undertone, the distorted voices of the performers invited us to "join up" with the Fellini-esque spectacle. But the freedom came with a price, betrayed by the

menacing laughter. Of particular interest was how the uniforms changed colors to the music. *7th place: 89.15*

**William Mason H.S., OH** • This Land took us on a journey to Africa, with the guard costumed as zebras, antelopes and giraffes. Musicians moved in character with the animals as symbols like those on tribal masks appeared in the drill. A thundershower brought the rainy season to the plains and towards the end of the safari, the large predator-eye flags seemed as if the entire jungle was watching us. *8th place: 87.65*

**Center Grove H.S., IN** • The majestic music of Baroque composer J.S. Bach imbued The Guardians with an ornate elegance; gradually bringing to life multitudes of motionless gargoyles perched across the field on ladders simulating cathedral towers. Delicately spreading double flags as if wings, the creatures attempted to take flight, but were stymied by the stony eternalness of their being. *9th place: 87.60*

**Lawrence Central H.S., IN** • Col Legno is named for the string instrument technique of stings sounded by the wood of a bow. Throughout, wood was used for visual effects, the on-field construction of physical sets and the intensity of rhythmic propulsion. A huge variety of amplified wooden sounds accompanied the physical appearance of an ax in the drill that was utilized to metaphorically chop wood. *10th place: 87.35*

**Ronald Reagan H.S., TX** • For the band's 10th anniversary of its first appearance in the BOA Grand Nationals Finals, their special sudden change of plume colors was updated with the addition of lights in Let It Shine. Lights on the uniforms supported the lights covering the field, creating a shimmer that seemed to make every blade of stadium turf come alive with the fluorescent pulsation of the sparkling music. *11th place: 87.30*

**Plymouth-Canton Ed. Park, MI** • The Last Dance was a peek at our uncertain world, starting carefree but interrupted by unnerving sounds and a flood of gray fabric leaving a trail of destruction. To "Time in a Bottle," the band formed a giant hourglass and poured from the top into the bottom like sifting sand, unable to recapture what was lost. Yet hope prevailed at the end, reminding us to never give up. *12th place: 84.95*

# New in 2014! Expansion of the National Concert Band Festival

New opportunities, quality educational experience

Starting in 2014, Music for All will provide world-class educational opportunities for additional bands to perform. The National Concert Band Festival will now include two stages (opportunities) for high school bands – “Featured Bands” on the Honors Stage at Clowes Memorial Hall and “Invited Bands” on the Festival Stage at the new Howard L. Schrott Center for the Performing Arts, both at Butler University. The National Concert Band Festival is part of the Music for All National Festival, presented by Yamaha. The 2014 Festival will be held March 6-8, 2014 in Indianapolis.

The new “Invited Band” stage is designed for up to 12 bands interested in experiencing a great, educational, “life-changing experience.” This opportunity will provide the same world-class offerings as the “Featured Band” such as master classes, leadership sessions, social gatherings, one-on-one conductor feedback and a gala awards banquet, but with more “hands-on” treatment such as multiple clinicians simultaneously working with bands, interactive audience participation and other aspects that will enhance the student’s experience. Dr. Tim Lautzenheiser will be the Master of Ceremonies in 2014 for the Invited Band Festival Stage.

Applying high school bands select on their application form which of the two stage experiences they are applying for.

## Featured Bands – Honors Stage

The Featured Band Honors Stage is the Festival experience that Music for All has presented since the Festival’s debut in 1992. Bands perform in beautiful Clowes Memorial Hall at Butler University. Up to 18 bands who apply for the Featured Bands experience will be selected to perform.

One-on-one mentoring for conductors. Each “Featured Band” will receive a one-on-one mentoring session for the ensemble’s conductors with one of the Festival evaluators or clinicians. This mentoring session affords the conductor the opportunity to engage one-on-one with the evaluator about the program and topics of interest to both the conductor and the mentor.

## Invited Band – Festival Stage

The Invited Band experience is for those bands that not quite ready to apply for a Featured Band performance but that want the opportunity for growth this enrichment opportunity provides. This experience is also for additional bands from the Featured Band programs.

Invited Bands will perform for nationally recognized evaluators and clinicians in a completely supportive non-competitive environment – to be invited is the achievement. All bands interested in the Invited Band opportunity must submit an application and recording.

The Invited Band experience is envisioned as an in-depth education experience. In addition to the performance, which includes written and recorded evaluation, each Invited Band will have a 30-minute clinic that

will involve three evaluators who will work simultaneously with each band. Each band’s conductor(s) will receive a 30-minute, one-on-one conductor-led session with an evaluator following each performance block. A face-view video of the conductor will be provided for the conductor evaluation session. Each band member will receive a DVD and CD package of their concert performance, and formal group photo. Bands will participate in audience time for each other. Student ensemble audience members will have the option to complete an evaluation form with positive comments and thought-provoking questions to provide additional educational experiences.

# Everything Beautiful Honors Chuck Campbell

Charles (Chuck) Frank Campbell, Jr., was respected nationally as a music educator, conductor and mentor to young music teachers.

In 2006, Chuck retired after 31 years as a public school band director. During this time, Chuck directed bands in Kentucky at East Hardin High School, George Rogers Clark High School and North Hardin High School. Under his direction, his marching and concert bands received national recognition. The North Hardin High School Band received both the Sudler Shield and the Flag of Honor from the John Phillip Sousa Foundation. Both the George Rogers Clark and North Hardin High School bands performed at the Midwest Clinic under his direction. In addition, the North Hardin Wind Symphony performed in such venues as the Kentucky Music Educators Conference, Bands of America National Concert Band Festival and Carnegie Hall.

He died July 30, 2011 after a four-month valiant battle with pancreatic cancer. In March 2012, Mr. Campbell was inducted into Music for All's Bands of America Hall of Fame.

In March 2014, Music for All's Honor Band of America, under the baton of Eugene Migliaro Corporon, will premiere *Everything Beautiful* by Samuel R. Hazo, commissioned in honor of Chuck Campbell.

About the commission for Mr. Campbell, Mr. Hazo says, "I need to let the piece speak for itself. Hopefully, it will capture everything people felt when they were around Chuck. As for my view of Chuck and his work with students, he believed in them, trusted them and was so beloved by them that they would do anything for him. There is no better subject than music for a teacher with that intangible quality. In short, the honor is all mine."

We asked band director Teresa J. Elliott, about the commission which she first envisioned. Ms. Elliott is in her 34th year of public school teaching and currently Director of Bands at Beaumont Middle School in Lexington, KY.

## Can you tell us about the idea of the commission?

The idea for a commission actually came to me on the morning I received the phone call letting me know of Mr. C's passing. I had an idea that his time on this earth was nearing the end and I wanted desperately to be alone in the midst of something greater than life itself. That morning I had ventured into one of the most beautiful areas of the Smoky Mountains I

had ever been...the sun glistening through the treetops and the sound of the rushing water beside the trail were eerily soothing... as if he was saying to me..."don't worry... I'm ok." It was one of the most painful, but uplifting times in my life. Perhaps it was the surroundings that allowed me to immerse myself in my thoughts and memories of this great teacher. It was during this time that I decided the best way to honor Mr. C was to have one of his best friends and colleagues compose a piece of music that would forever be a fitting tribute to the life of Chuck Campbell. At the time, I had no idea of a title...but I knew I wanted Sam Hazo to write it and I knew it had to be an incredibly moving and musical work.



**Can you describe the piece musically and how is it a fitting tribute to Mr. Campbell?**

Strangely enough, Mr. Hazo tells me the title is from a line in the movie "Sleepless in Seattle." The main character (Tom Hanks) was describing his deceased wife. He said, "She made everything beautiful." Mr. Hazo could not think of a better description of Chuck Campbell.

**What is your history and background with Chuck Campbell?**

In the fall of 1969, I was a freshman at George Rogers Clark High School when Mr. Campbell began teaching there. I remember that I was the very last chair clarinetist (of 30 some clarinetists) in the band...in fact, I was so bad, I didn't even get to march my freshman year except once or twice at a football game! However, Mr. C was such a motivating, encouraging, and at times, a downright scary force...it did not take me long to realize that I wanted to devote my life to becoming a great teacher like him. By the end of my freshman year, I had moved, via challenge after challenge, from last chair to second! I was under Mr. C's direction for all four years of my high school career and continued to work with him at GRC following my graduation. He introduced me to "Hawk" (Dr. Robert Hawkins) at Morehead State University, another one of my great mentors.

However, one of my greatest memories of all was when he was sitting at Kentucky Music Educators Association in 2005 and told me that I needed to submit a tape for the Midwest Clinic before he retired. In fact, he said, "you need to do it THIS year!" Well, I had my doubts, but I knew that you simply don't say no to Chuck Campbell...so I left KMEA, put together a program, rehearsed my band, and submitted the recording. Two months later, we got the acceptance letter! Mr. Campbell went to Chicago with me for the required June orientation meeting for performing ensembles, and he guided me EVERY step of the way. I was so incredibly proud to have him guest conduct on that special concert. But I was more proud to introduce him to my students at Beaumont Middle School and explain to them how Mr. C developed my love for music. It didn't take my students but one rehearsal with Mr. Campbell to understand why I loved him so much. He had a unique way of kicking you in the butt (figuratively, of course) one moment, and picking you right back up the next, with that infectious smile of his followed by a hug.

**The Honor Band of America will premiere the piece in March 2014 at the Music for All National Festival. Can you tell me what that means to you?**

To have "Everything Beautiful" premiered by the 2014 Honor Band of America is absolutely incredible. Mr. Campbell believed so very much in the mission of the Bands of America.

What an incredible honor for an incredible man! I thank God every day for placing Mr. Campbell in my life. He has been a guiding force for my entire teaching career. I miss him so. I am so excited for this work to be premiered. I know he will be listening.

I am especially grateful for Sam Hazo, Eric Martin and Eugene Corporon for their part in making this dream a reality.

**Your involvement with Music for All/Bands of America goes back many years. Can you talk about how you've been involved with the organization and when?**

Interestingly enough, my initial involvement with Bands of America was with Mr. Campbell the GRC Band in 1975 when they competed in Whitewater, Wisconsin for the Summer Marching Bands of America. I was a staff member for the

band and as usual Mr. C took care of me, introducing me to everyone. He was always watching out for me. Following that experience that summer, I, too, fell in love with the mission and the enthusiasm of the organization. When I finally became a teacher, I brought my Pride of Paoli Band students there every summer. In fact, one summer over 65 students enrolled in the summer symposium at Whitewater! I was hooked! In addition, I worked on the leadership staff with Dr. Tim for several years, and was even the SWAG team coordinator a couple of years. All this is thanks to the guidance of my great mentor, Mr. C.

Mr. Campbell introduced, fostered and nurtured my love for music. I credit my teaching, my vision and my love for students via music to Mr. Campbell. His influence will forever live on in each of the wonderful students he developed and in the students of those students...and the students of those students.

# Music (and arts) for All in the 21st Century

“Humans need to communicate, share, store and create. As a species, we’ve engaged in these functions for centuries. There’s really nothing new about them. What is new are the forms, or tools, that students use to meet these needs.”

Over the several months leading up to last November’s elections, I was inundated (as I’m sure you were) with campaign ads touting the virtues (or lack thereof) of candidates of all persuasions and ilk. These ads showcased each candidate’s commitment and ability to address and solve our largest challenges, most important human needs and their ability to perpetuate and allow us to attain the quintessential “American Dream.” Beyond the economy, much emphasis was and still remains placed on maintaining or reclaiming our ability to compete and lead globally. The conversation about our young people was often about the loss of our educational edge. We’re convinced, and maybe rightfully so, that we are failing to educate and prepare our children for the competitive challenges of the 21st century. It’s a valid conversation, however, I feel a responsibility to bring another voice into the discussion.

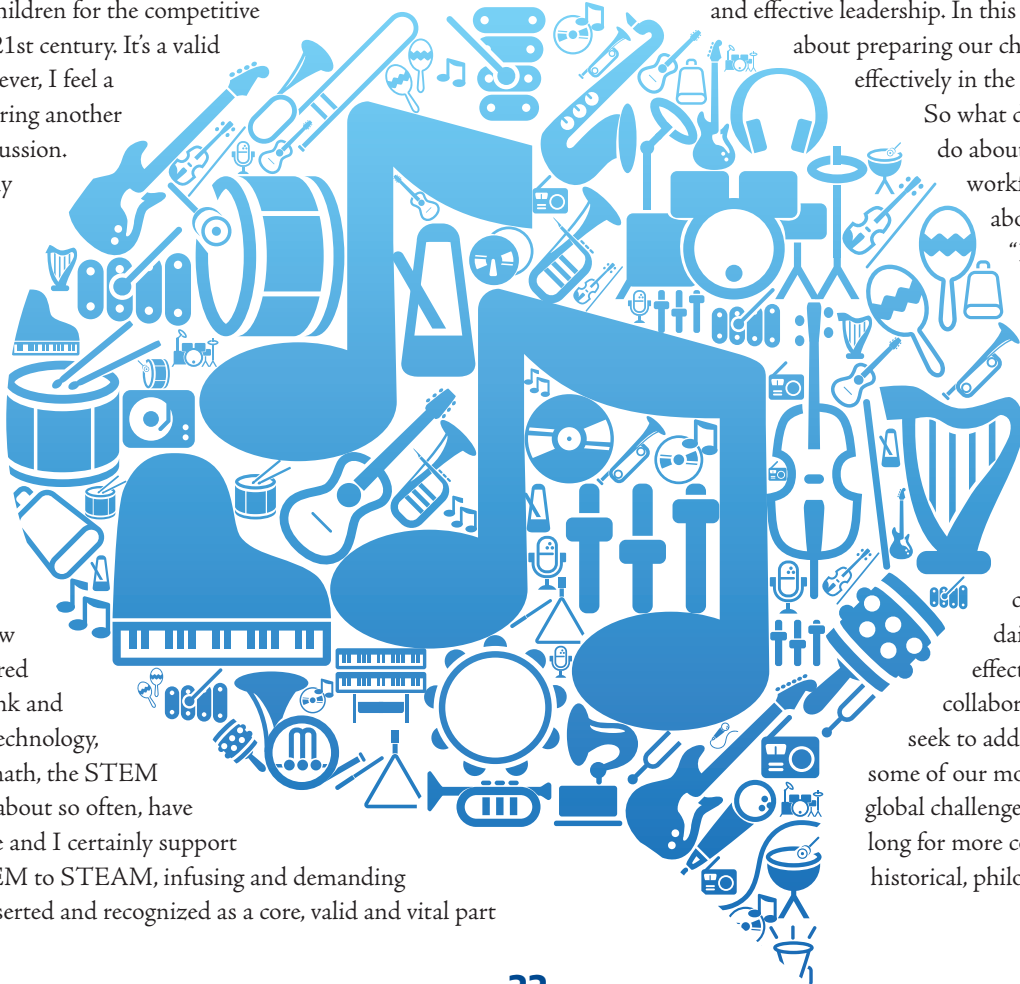
Folks around my office sometimes fondly (or not so fondly) know and label me “a diploma snob.” For some, a diploma snob means where you went to school, but for me, and I own this observation, it’s more about how you’ve been prepared and trained to think and reason. Science, technology, engineering and math, the STEM concepts we hear about so often, have their rightful place and I certainly support moving from STEM to STEAM, infusing and demanding that the *arts* be inserted and recognized as a core, valid and vital part

of the learning and achievement equation. However, my support for STEAM is more deeply rooted in my “snobbery.”

What I care about in every student and every professional I encounter, be it personally or for Music for All, are their “abilities to think and reason.” I look for and build my faith in the future of our children, our nation and our culture on the ability to teach children “how to think and reason,” a very different concept than “what to think.”

I am a product of the arts, infused naturally and effectively, in a total education. Engagement in the arts (and other programs of human engagement), coupled with core academic subject matter, gave me the opportunity and platform to help understand and advance human, societal and business relationships. Understanding not just that things work, but how they work, why they work and realizing their impact on ones’ self, and others, form the essence of prepared and effective leadership. In this context, I am a “snob” about preparing our children to thrive effectively in the future.

So what does this have to do about the 21st century workforce? For me, it’s about the 21st century “Life Force.” I’ve traveled across the country speaking to students, teachers, administrators and parents with an “artistic” interest that drives my professional commitment. Almost daily, I struggle to hear effective dialogue and collaboration as our leaders seek to address, solve and resolve some of our most difficult local and global challenges and conflicts. I long for more conversation with the historical, philosophical and “civil”





teachings and dialogue about the development of America's strength and destiny from an ultimate commitment to the common good, general welfare and societal empathy and commitment to the wellbeing and advancement of "the least of those." I miss experiencing our American commitment to active listening, the common good and the art of compromise. Too often, the dialogue (or absence thereof) is centered on winners and losers, my way or the highway, and to the winner goes the earned and rightful spoils.

I often ask what our student performing arts ensembles would be and sound like if they did not learn skills about individual and ensemble commitment to concepts like intonation, leading and following, collaboration and exchange of thoughts and ideas, or if they refused to accept and see the benefits of leadership. I can only imagine the unintended discordant result of an ensemble whose idea of excellence is "every man or woman out for himself or herself."

Great ensembles know, and are taught, that great results only come from collective achievement. The whole is only as successful as the individual parts comprising it. Performance responsibility of each individual is necessary for ensemble success. In other words, all members of the ensemble have a vested interest in the skill development, well-being and achievement of others. "We're in it together," is a vital and essential factor and tool for success. We become great when each and every member not only understands "the what" and "the how", but also "the why." It is then that they can lead themselves with effective decision-making and collaboration for the "common good." If only all of our leaders, including government leaders, shared that common understanding. In the end the "audience," like our world, benefits.

"The combination of core academic subjects, 21st century themes and 21st century skills redefines rigor for our times. However, rigor traditionally is equated with mastery of content (core subjects) alone, and that's simply not good enough anymore."

"Growing proportions of the nation's labor force are engaged in jobs that emphasize expert thinking or complex communication- tasks that computers cannot do."

"The assessment is forward looking, focusing on young people's ability to use their knowledge and skills to meet real life challenges, rather than merely on the extent to which they have mastered a specific school curriculum."

Harvard Professor, Shelley Carson, wrote the following for the Huffington Post after a 2010 G-20 Summit meeting: "The G-20 Summit in Toronto is now over and, not surprisingly, one of the conclusions of the conference was that in order to attract investors, nations need to provide an 'environment that promotes creativity.' From politics to business to education to sports, creativity is one of the buzzwords of this decade. We used to think of creativity as the province of artists, musicians and writers. Now we're waking up to the fact that all facets of modern life demand creative input."

Most social and educational scientists agree that creativity is a necessary core "skill." Creativity is an essential tool for 21st century success. And the beauty of our opportunities is that the human brain is built for creativity. Our responsibility as practitioners and promoters of music education is to ensure that our children have access, opportunity and skills necessary to discover and activate their God given and innate abilities. Our individual, organizational and human success depends on it. In short, Dr. Carson summarizes that, "creativity is important for artists, writers, musicians and inventors; but it is also crucial for societies, businesses and individuals who need to juggle fulfillment with the demands of the rapid-change culture. You not only need to be creative to enhance your life, you need it to survive."

Our society is replete with evidence of success authored by artistically inspired achievers. A 2009 Harris Interactive poll shows that three-quarters of Fortune 100 executives were involved in some type of music program while in school and research shows that the longer executives participated, the more successful they became in life.

"The skills that they are learning, the things that they're doing as a part of their music program, and their leadership experiences ... these are the things that I look for when I'm hiring people. When I see on the resume that there is some type of artistic activity and leadership experience, I know that is someone I'm interested in interviewing. It's the skills that aren't taught anywhere else that make that person stand out above the rest."

It is no accident that Indiana is a state where one of its (and America's) largest privately held corporations is led by the corporation founder's son's middle school band director. Entrepreneurs clearly recognize and are attracted to talent that includes evidence of creativity, creative instinct and problem solving in their repertoire. It is further no accident that Music for All is blessed to be governed by leaders who themselves (or their children) are products and beneficiaries of quality music education. They are entrepreneurs, corporate executives, lawyers, accountants and community leaders who see and are passionately committed to music and arts education.

The arts, and particularly ensemble experiences in the arts, have always provided an edge for development and appreciation of creativity, in an environment defined by collaboration, group and individual problem solving, mutual respect and cooperation. If it is true that success and a successful workforce in the 21st century require critical thinking, creative problem solving, innovation, effective communication and team work, then every American child's scholastic day should include an active "hands-on" experience in the band, orchestra, dance, theatre, art and/or choir room. The collaboration necessary for success (student to student, student to teacher, student to parent, parent to teacher and everyone to their community – the audience and beneficiary) is inherent in the process. The goal is not professional artistry. They all will not become Christopher Martin (Principal Trumpet of the Chicago Symphony), renowned actress Jennifer Morrison or even Carl Cook or Kem Hawkins (CEO and President, respectively, of the Indiana-based Cook Group), but they will be better prepared and more able to compete and contribute meaningfully in the 21st century.

The discussion about 21st century skills and creativity as a necessary and essential component is not new, nor is it likely to go away, at least not before we begin to look to the needs of the 22nd century. One need only look to *Time's* 2005 article on the subject, still valid and valuable in 2012. At Music for All, we are committed to being a catalyst to ensure that every child across America has access and opportunity to participate in active music making in his or her scholastic environment. Our name and mission require no less of us. We believe in music education, music in our schools and Music for All.

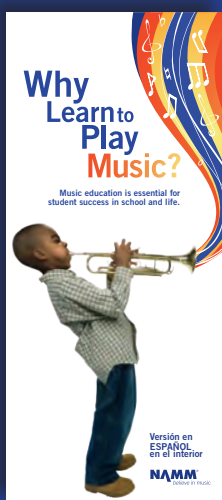

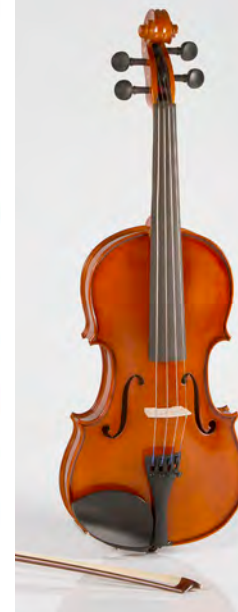

# A personal perspective on the BOA Honor Band Rose Parade experience

Erin Fortune has been working with Music for All for the past two and a half years, first in the Participant Relations department and now as the Marketing Coordinator. She is a graduate from the Music Industry Management program at Ferris State University in Michigan and is a former Percussive Arts Society Intern and a Yamaha Corporation of America, Band and Orchestral Division Intern.



When we found out that Music for All was invited to bring an Honor Band to the 2013 Tournament of Roses® Parade, I was told to get ready for the experience of a lifetime. I had worked with students who participated in our fall Bands of America Championships, the Music for All National Festival (including the Honor Band of America, Honor Orchestra of America and Jazz Band of America) and the Music for All Summer Symposium, but I was told to expect students who were even more excited about this particular experience. After all, Music for All is only able to apply every four years, the experience happens in sunny California and the students get to march on national television. Who wouldn't be excited about that?

And excited they were. It felt like from the very beginning of their journey when the acceptance letters first went out these students were already finding each other on Facebook and starting to build the community of their band. I had so much fun reading the interactions that were happening between students in the Facebook group, and watching groups of students starting to form friendships. There were at least a couple posts every day, even back in April 2012.

I remember sitting in the van as we drove from Indianapolis to Chicago to catch a flight after all of the Indianapolis flights were cancelled, and reading posts from students talking about how excited they were, updating everyone on the status of their trip and even making plans to meet up with each other at the various airports through out the country.

I think it's incredible how technology helps these friendships form. Some of these students felt like they had been friends forever instead of just strangers meeting each other for the first time when they got off the plane in California.

The next nine days were a blast. I had the opportunity to watch numerous rehearsals and I was always impressed with the dedication of the students. The event itself is tiring; the students get up early in the morning and don't go to bed until late at night- the whole day playing music. But they were always so full of enthusiasm and respect for the faculty members who were working with them, and the chaperones who were there being their parents away from home.

When I try to explain the amount of dedication these students had, and how hard they worked to accomplish the goals of group, I don't believe I do it justice. Frank Troyka, one of the faculty members for the 2013 Honor Band in the Tournament of Roses® Parade summarizes it beautifully in a video clip that was captured during a rehearsal.

"They are starting to come together and create an identity for themselves. There is even a culture at work now where the kids are starting to all put in the work ethic that's unique to this group. I can see them setting aside their individual band identities to come together and really become the Bands of America Honor Band for 2013"

I find myself very envious of the members of the 2013 Bands of America Honor Band, not only because they had this experience that I only dreamed of as a high school student, they worked with incredible world-class faculty and increased their musical skill, but even beyond that, I'm envious of all of the connections these students have made at such a young age. There is no doubt in my mind that many of these students have made friendships that will last them a lifetime.

"I spent the week of a lifetime with 299 amazing people from all over the country," said member Ethan Thompson, tuba player from Acworth, Georgia. "We marched in the Tournament of Roses Parade

and we spent many days touring and hanging out around LA and Hollywood. And I honestly wish that week could have never ended, because I made so many new friends that I didn't want to say goodbye to. At the beginning of the week, most of us didn't really know each other. But by the end of the week, it was like we had known each other for a lifetime."

In my position here at Music for All, I'm lucky enough to be able to take part in interviews of students, and hear from them directly about what the experience meant to them and what was most memorable. From the conversations that happened with the students I talked to after the closing banquet, a few things stuck out in my mind.

The students raved about the world-class faculty that they were working with all week. More than one student shared funny and extremely memorable quotes from Matt Harloff during rehearsals.

A favorite moment shared by many was marching in the parade and getting to TV corner. One student in particular talked about

how everyone had warned them and tried to prepare them for what it would be like when they reached the turn...but the thing that caught her off guard was turning the corner and seeing this gorgeous view of the mountains (while being surrounded by people and cameras!)

Every single student I talked to spoke about the friendships they made during the week being life-changing, and knowing that they had this wonderful opportunity to meet incredible musicians just like them from all across the country.

"I've met so many people that I never would have met had I not come," said Julianne Clements, one of the four drum majors of the Bands of America Honor Band. "Marching in that parade and seeing

the millions of fans out there, and then knowing there are a million viewers at home watching the parade, and just being a part of that and getting to come around that corner and seeing the street lined with people – that's a moment I'll never forget."

It is an honor and privilege for each of us at Music for All to be able to work with incredible students and music educators. This band made us proud everyday through the experience, and I wish that someone would have recorded the reaction in the stands on Colorado Boulevard as the staff, chaperones, family and friends watched the band march by. Everyone in our section was grinning from ear to ear and busting with pride. Thank you, honor band members and faculty, for giving us the opportunity to experience so much joy in watching your growth to become what we saw that day.

They came from two nations, 31 states, 13 universities and more than 150 of America's best high schools. Together they became ONE band representing the mission and vision of Bands of America and Music for All.

And in closing, I'll leave you with one more quote that has stuck in my mind since I heard it at the closing banquet. I have yet to hear anyone who can summarize an event as well as Mr. Eric L. Martin, President and CEO of Music for All.

"The 2013 Bands of America Honor Band and experience in the Pasadena Tournament of Roses® parade is now history. It will never come again. All we have left are the memories we have created for ourselves, and so many others along the way. Our only request is that you continue to be who you are... the most excellent citizens of the world we could have imagined bringing together for this music making adventure. You are our family and you are Music for All."

## Music For All receives NEA Grant to support Summer Symposium

*Grant is one of 832 Art Works grants totaling \$23.3 million in funding nationwide*

National Endowment for the Arts (NEA) Chairman, Rocco Landesman, announced that Music for All is one of 832 non-profit organizations nationwide to receive an NEA Art Works grant. Music for All is recommended for a \$20,000 grant to support the Directors' Academy component of the Music for All Summer Symposium at Ball State University.

The Music for All Summer Symposium at Ball State University is a weeklong camp for both high school students and directors. This grant will support the Directors' Academy, which is a weeklong, instrumental music, professional development program. Music teachers will improve their classroom rehearsal techniques, conducting, score study and repertoire selection by working with field experts and a live student ensemble. The camp is at Ball State University in Muncie, Indiana from June 24-29, 2013.

"I'm proud to announce these 832 grants to the American public including Music for All's Summer Symposium Directors' Academy," said Chairman Landesman. "These projects offer extraordinary examples of creativity in our country, including the creation of new work, innovative ways of engaging audiences, and exemplary education programs."

"Music for All is honored to be receiving one of the NEA Art Works grants. This grant will allow us to enhance our Directors' Academy curriculum and make the Music for All Summer Symposium more accessible and available to more directors, including young educators just starting their careers and collegiate students interested in becoming future music educators," said Eric L. Martin, President and CEO of Music for All.

In March 2012, the NEA received 1,509 eligible applications for Art Works requesting more than \$74 million in funding. The 832 recommended NEA grants total \$22.3 million, span 13 artistic disciplines and fields, and focus primarily on the creation of work and presentation of both new and existing works for the benefit of American audiences.

Applications were reviewed by panels of outside experts convened by NEA staff and each project was judged on its artistic excellence and artistic merit.

Music for All hopes that this Grand National's initiative becomes a catalyst to inspire a student participant lead and driven commitment to create, determine and support a special Bands of America project benefiting others at each Grand Nationals, beginning November 2013. "At Music for All, we want to teach students about even more than music. We are committed to helping to prepare students to be great citizens and professionals. One of Music for All's core values is Leadership," said Eric Martin, President and CEO of Music for All. "We lead through positive action and are committed to serving others for the greater good of society. While the devastation of Hurricane Sandy is terrible, it is an opportunity for our students and communities to practice real leadership and engage in doing so."

Music for All also received support for the Hurricane Relief initiative from its partners as well as the Indianapolis area community. Pepwear provided t-shirts that were the uniforms of the volunteers, Sharp Business Systems donated printing services and the Home Depot donated the collection buckets.

## Indianapolis-Based Music for All Commits to Staying in Indy and Holding Events Through 2023

*11-year deal with the city will create \$225 million in economic impact*

Indianapolis-based Music for All announced its plans to keep its office and staff in the city at a press conference in Lucas Oil Stadium on November 10, 2012, in addition to keeping its events in Indianapolis through 2023. This 11-year extension to the existing agreement will generate an additional estimated \$225 million in economic impact and bring in more than 600,000 visitors to Indianapolis. The organization moved from Chicago to Indianapolis in 2003.

"The City of Indianapolis will benefit from the economic impact attributed to Music for All's commitment, but also the impact of

future leaders coming to Indianapolis annually for events," said Indianapolis Mayor, Greg Ballard. "Students having a positive experience in Indianapolis during one of Music for All's signature events will encourage them to return to Indianapolis to attend college, enter the workforce, or visit again with family and friends."

Programs and events held in Indianapolis as part of Music for All include the National Festival in March with an attendance of 3,000, marching band Super Regionals that welcomes 11,000 in October, and Grand Nationals each November that draws 39,000 visitors to the city.

As a youth, Littleton represented his home state of West Virginia in the McDonald's All American Band, performed in the All-American Jazz Band, minored in music at West Virginia University, studied at the Berklee College of Music and worked in the music industry for over 10 years before moving to Franklin to raise a family.

Littleton has no doubt been instrumental in raising much-needed funds for the new Hillsboro Middle School Band program, but his impact is much larger than that. "His impact reaches further than dollars and cents," said Cameron Gish, Band Director, Hillsboro Middle School. "His innovative ideas have transformed the way we think about band at Hillsboro School, and within our own county. I am constantly inspired by his selfless attitude,

# 2013 Fall Championships Terms of Application

## Schedule Changes and Refund Policy

Because Bands of America uses a large number of collegiate facilities, certain dates on this schedule cannot be finalized until affected conferences issue final fall football and television schedules. Any schedule changes will be communicated to all participating bands. "Postmark" dates and Participation Cooperative Fees will be "protected" should a site or date change require you to transfer to another BOA Regional date/site, or withdraw. If a change occurs, you will have until an announced date to make a change and still protect your postmark date and Participation Cooperative Fee. **Participation Cooperative Fees are not otherwise refundable or transferable from one event to another.** Bands that withdraw from an event will not receive Cooperative tickets and will only be entitled to a refund per the refund policy. We reserve the right to cancel a Regional if 18 bands are not registered by May 13, 2013.

## Housing Bureau for Super Regionals and Grand Nationals

All Competing bands and their booster groups utilizing hotel accommodations for their stay during the event are **REQUIRED** to make their hotel reservations through the BOA Housing Bureau for the respective event. The Housing Bureau has been set up to secure enough hotel rooms at the lowest block prices to accommodate all the bands' needs for the event. Housing Bureau form and information will be sent separately. Bands that violate this policy will not be permitted to perform and forfeit all Participation Cooperative Fees.

## Parking

Surrounding stadium parking lots are not necessarily included in rental of facilities used by BOA. A Parking Pass Request form will be included in your May mailing that will designate which Championships require a payment for buses/trucks. Most BOA events have bus/truck parking that is free to the participating bands including Grand Nationals; however, some Regionals require a parking pass - parking passes have been approximately \$15 - \$30.

## Regional Championships

Fees for Early Season Regional Championships will be \$650 per band, per event. Fees for Regular Season Regional Championships are \$800 per event. Some Fall Regional Championships will have a parking fee of up to \$30 per bus/truck. Amounts will be communicated in your May mailing. ## Super Regional Championships

Fees for Super Regional events will be \$800 per band, per event. All Super Regional events will have a parking fee of up to \$30 per bus / truck. Amounts will be communicated in your May mailing. **With the BOA Super Regional Championship Participation Cooperative program, your band will receive:**

- **25 Field Passes\*** for Preliminaries (Note: All bands performing in Finals automatically receive 25 Finals Field Passes at no charge.)
- Ticket Options\* (BOA will provide a choice of forty (40) General Admission Super Regional Finals Tickets or twenty (20) tickets to each day of prelims. You will indicate your preference on the Information Sheet.)
- Up to 6 Director / Staff Badges good for admission to Prelims and Finals
- All bands will receive a High Camera Instant DVD of your preliminary performance. (Bands that perform in Finals will also receive an instant copy of their Finals performance.)

\*Face value of tickets and passes: at least \$1,345.

**Day of Performance** will be based on a participant's choice of day of performance and distance from the event criteria.

- The day of performance and prelims performance draw (performance block assignments) will be made on April 30, 2013.

**The structure/procedure (in order of consideration) for Day of Performance is as follows:<sup>1,2</sup>**

- Any 2012 BOA Regional Champion, the 2012 Grand National Champion or the 2012 Grand National Class Champion enrolled in the event may choose its day of performance (Friday or Saturday).
- Bands that request a Friday performance draw slot on their enrollment application will be assigned to perform on Friday.
- The 30 bands that are the farthest distance from the performance venue will be given priority for a Saturday Prelim performance time. Additionally, after Saturday slots have been filled, the remaining participating bands (those geographically closest to the performance venue), will have a Prelim performance time on Friday. Friday performances will begin no earlier than Noon and be completed by 8 p.m., and consideration will be given to create a workable schedule to allow bands to perform and still participate in their school commitments on Friday night.
- In the event that performance spots remain in the show, bands that apply after the postmarked date of Jan. 31 will be placed in the earliest prelim times on Friday.
- From time to time, bands (for whatever reason) withdraw from events, creating opportunities for "waitlist" or other new entrants.

<sup>1</sup> To have assignment and selection rights, a band must have applied for the event by the Jan. 31 postmark date. Thereafter, rights exist (on a first-come, first-served postmark) only for remaining spots after assigning other bands.

<sup>2</sup> All issues of distance to be determined by using mileage information obtained from Google Maps.

**Participation Cooperative Tickets, Number of Bands in Finals, Judging Panels:**

- BOA will provide a choice of forty (40) General Admission Super Regional Finals Tickets or twenty (20) tickets to each day of prelims.
- Twelve (12) or fourteen (14) bands will advance to finals, depending on the total number of bands in the show (12 finalists if less than 45 bands are enrolled, 14 finalists if 45 or more enroll).
- One panel of judges will evaluate the event if less than 50 bands enroll by May 13. If more than 50 bands are enrolled by May 13, a new panel of judges will evaluate finals.

## Grand National Championships

There will be two preliminary events—Prelims 1 and Prelims 2—with up to 45 bands each. Each prelims contest will have a separate adjudication panel. Bands of America recognizes that the travel distance for some bands will necessitate missing one to two days of school just for travel time. In order to retain the integrity of Grand Nationals as a national championship and enable bands from across the nation to participate, BOA will allow bands traveling from schools located more than 325 miles (one way) from Indianapolis to choose to either be part of the regular performance time draw OR choose to participate in a special draw for the first block of times in the Prelims 2 contest. Bands from schools more than 325 miles (one way) from Indianapolis must select their preference on the application form.

**Thursday Prelims Volunteer Opportunity:**

It is feasible for groups within an approximate 200 mile radius of Indianapolis to perform on Thursday, return home for a full day of school on Friday, then return to Indianapolis Friday after school or Saturday morning for the Semi-Finals and Finals shows. Some bands may find this preferable to an extra night's housing. Bands that volunteer will be assured performance times prior to 8:30 p.m. Bands can select this option on the application form.
